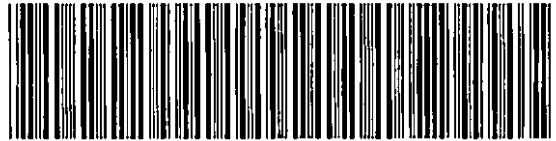

DATE OF ADOPTION

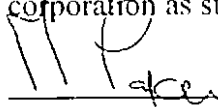
