FIRST The name of this corporation is Classic Roofing, Inc.

SECOND. Its registered office in the State Of Florida is to be located at 7305 Abington Avenue, New Port Richey, Florida 34655, County of Pasco. The registered agent in charge thereof is James W. Reed, 7305 Abington Avenue, New Port Richey, Florida 34655.
