**ARTICLE I  
NAME**

The name of the corporation is: Missco Maids, Incorporated

**ARTICLE II  
CORPORATE PURPOSE AND POWERS**

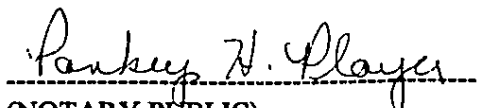
