

**ARTICLES OF INCORPORATION
OF

**ARTICLE I
CORPORATE NAME AND PRINCIPAL ADDRESS**

The name of this corporation is Affordable Wheelchair Transport, Inc., and the initial principal address of the corporation is 926 Myrtle Avenue, Clearwater, Florida 34616.

**ARTICLE II
NATURE OF BUSINESS AND POWERS**

The general nature of the business transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III
CAPITAL STOCK**

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock having a par value of \$1.00 per share.

**ARTICLE IV
TERM OF EXISTENCE**

This corporation shall have perpetual existence.

**ARTICLE V
REGISTERED AGENT, INITIAL REGISTERED OFFICE**

The name of the registered agent of the corporation is Patrick Shaughnessy. The address of the initial registered office is 926 Myrtle Avenue, Clearwater, Florida 34616. The Board of Directors from time to time may move the registered office and/or the principal office to any other address in the State of Florida.

ARTICLE VI
BOARD OF DIRECTORS

This corporation shall have one director initially. The number of directors may be either increased or diminished from time to time by bylaws adopted by the stockholders, but shall never be less than one (1).

ARTICLE VII
INITIAL DIRECTOR

The name and address of the director of this corporation are Patrick Shaughnessy, 926 Myrtle Avenue, Clearwater, Florida 34616. The person named as initial director shall hold office for the first year of existence of this corporation or until a successor is elected or appointed and has qualified, whichever is first.


ARTICLE VIII
INCORPORATOR

The name and street address of the person signing these Articles as the Incorporator is Patrick Shaughnessy, 926 Myrtle Avenue, Clearwater, Florida 34616.

ARTICLE IX
AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholders' meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.




