The undersigned natural person who is licensed or otherwise legally authorized to practice law or otherwise perform the services of attorney-at-law, in the State of Florida, hereby forms a professional corporation, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I
NAME

The name of the corporation is OLIVER HARRIS, III, P.A.

ARTICLE II
PURPOSE

The purpose of the corporation is to maintain offices for the practice of law in the State of Florida. The corporation may transact such other business as is necessary or proper to carry out the purposes and goals of the corporation, including, but not limited to the investment of the corporate funds for the mutual benefit of the shareholder(s).

ARTICLE III
CAPITAL STOCK

The total number of shares of capital stock which the corporation shall be authorized to issue is 300. Such shares shall be of a single class of common stock, and shall have a par valued of One (\$1.00) Dollar per share.

CAPITALIZATION

The amount of capital with which the corporation will begin to practice the legal profession is not less than One Thousand (\$1,000.00) Dollars.

The corporation shall have perpetual existence.

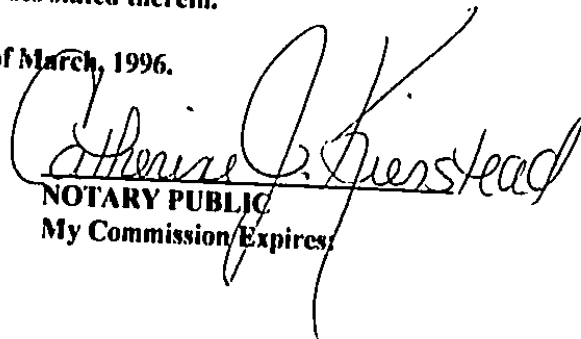
