The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I -- NAME**

The name of the corporation shall be RCI DEVELOPMENTS, INC.

**ARTICLE II -- ADDRESS**

The mailing address and principal place of business of the corporation shall be:

**ARTICLE III -- PURPOSES**
