ARTICLE I.

CORPORATE NAME

The name of this corporation shall be: Vacc. Enterprises,  
Inc.

ARTICLE II.

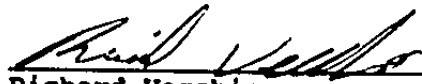
