ARTICLES OF INCORPORATION OF  
GAGNE CONSTRUCTION, INC.

THE UNDERSIGNED does hereby subscribe to, acknowledge and file the following Articles Of Incorporation, for the purpose of operating a Corporation under the Laws of the State of Florida.

ARTICLE I - NAME:

The name of this Corporation is GAGNE CONSTRUCTION, INC..

ARTICLE II - DURATION:

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE:

This Corporation is organized for the purpose of transacting any and all business lawful and permitted under the Laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK:

This Corporation is authorized to issue 500 Shares of \$1.00 Par Value common stock, which shall be designated "common shares". 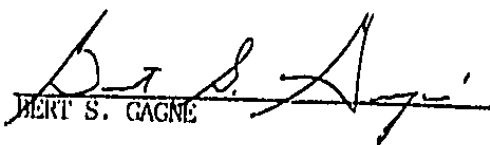
