ARTICLES OF INCORPORATION

The undersigned, a natural person competent to contract, acting as incorporator of a corporation under the Florida General Corporation Act, Chapter 607, <u>Fla. Stat.</u> (1993), as amended, adopts the following Articles of incorporation for such Corporation.

Article 1 Name

The name of this corporation is:

Article 2
Duration

The duration of this corporation shall be perpetual, commencing on the date these Articles are filed in the office of the Secretary of State of Florida.

Article 3
Purpose

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and Fiorida.

Article 4 Capital Stock

The corporation is authorized to issue 1,000 shares of common stock with each share having a par value of \$.001. All shareholders shall have preemptive rights in future stock sales by the corporation.

Article 12 Powers of Directors

The directors shall have power to make and to alter or amend the Bylaws; to fix the amount to be reserved as working capital; and to authorize and cause to be executed

mortgages and ilens, without limit as to the amount, upon the properly and franchise of the corporation. With the written consent of the holders of a majority of the capital stock issued and outstanding, the directors shall have the authority to dispose of, in any manner, the whole property of this corporation.


