ARTICLES OF INCORPORATION OF MOTHER & DAUTHER ELDERLY CARE, INC.

ARTICLE I - NAME

The name of this corporation is MOTHER & DAUTHER ELDERLY CARE, INC.

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
