ARTICLES OF INCORPORATION OF ASHLEY RENEE INTERIORS, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

Article I

The name of this Corporation shall be Ashley Renee Interiors, Inc.

Article II
