

ARTICLE I - NAME

The name of this Corporation is SLONAKER & OLSEN, P.A., Attorneys At Law.

ARTICLE II - DURATION

This Corporation/Professional Association shall have professional existence commencing on the date of the filing of these Articles of Incorporation with the Department of State.
