ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a Corporation under the Florida General Corporation, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is:

The period of its duration is perpetual.

The purpose is to engage in any activities of business permitted under the laws of the United States and Florida, including the buying and selling of automobiles, recreational vehicles and boats.

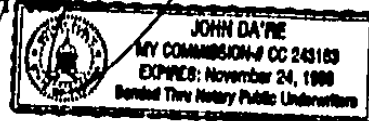
