The undersigned, for the purposes of foregoing a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation.

ARTICLE I  
Corporate Name and Address

The name of the corporation is Pro Edge Fitness, Inc. located at 10198 NW 47th Street Sunrise, Fl 33351.

ARTICLE II  
Term of Existence
