I was recently advised that the above referenced corporation of which I am the sole stockholder was dissolved because I had not filed the annual report. I'm sorry, but I was a) not aware that I had to do this, and b) not informed via mail, because I had all my mail forwarded to a new address and had on September 11th, 1998, notified the Department of Corporations I would be changing my mailing address. Since then, I had spoken with Michele in your reinstatement offices and she had informed me the mail had been returned to your offices.

Again, I apologize for the irresponsibility on my behalf, to not know there was such a thing as an annual report, but after speaking with Michele, she had informed me the \$750 late reinstatement fee would be a one-time waived fee and I could reinstate my corporation for a check in the amount of \$150.00.

I had previously submitted a check in the amount of \$43.75, to change some information on the corporation and to receive a certificate of status. Per your request, I am subtracting the \$43.75 from the \$150 to give the Division of Corporations a check in the amount of \$106.25 to reinstate my company.
