time is 1,000

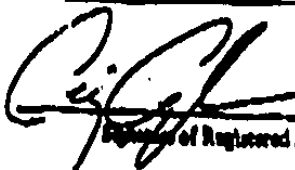

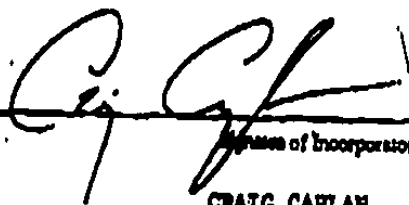
