THE STATE OF FLORIDA

KNOW ALL MEN BY THESE PRESENT:

COUNTY OF DRANGE

That the undersigned, natural person(s) of the age of at 7 least eighteen (18) years, acting as Incorporator(s) of a Corporation under the FLORIDA Business Corporation Act, do hereby adopt the following Articles of Incorporation for such Corporation, to wit:

#### ARTICLE I
