The undersigned do hereby subscribe to, acknowledge and file the following Articles of incorporation \hat{R} purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation is RACIN' RADIOS BY COMM SPECTRUM, INC.


