ARTICLE I - Name

The name of this corporation is BATTLE CREEK HUNT CLUB, INC.

ARTICLE II - Duration

This corporation shall have perpetual existence.

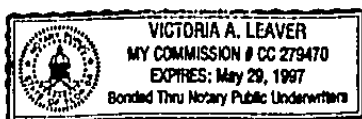
