ARTICLE I. NAME.

The name of this corporation is: TREASURE COAST
CONSULTING, INC.

ARTICLE II. NATURE OF BUSINESS.

The nature of business to be transacted by the corporation
shall be:

A. To plan, design, sell and provide implementation for
information systems and to perform such other activities
related to said nature of business.

B. To engage in any activity or business permitted under
the laws of the United States or of the State of Florida.

ARTICLE III. CAPITAL STOCK.

This corporation shall have one (1) class of common stock
