I, the undersigned, being a natural person of legal age, do hereby desire to form a Corporation under the Laws of the State of Florida, and do hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation shall be CENTURY MILLWORK, INC., a Florida Corporation.

ARTICLE II

Every Director, Officer, employee or agent of the Corporation shall be indemnified by the Corporation against all




