I, ANDREW E. FOX, do hereby incorporate myself for the purpose of becoming a corporation for profit under Florida law.

ARTICLE I

The name of the corporation is: THE FOX ADVERTISING AGENCY, INC..

ARTICLE II

This corporation is a full service marketing and advertising agency for all types of business. The corporation may also conduct other related enterprises not prohibited by law.

ARTICLE III

The aggregate number of shares which this corporation is authorized to issue is Ten Thousand (10,000), all of which shall be common shares with a par value of One Dollar (\$1.00) per share.

Each shareholder has full preemptive rights to purchase any shares held or owned by other shareholders of the corporation.
