**ARTICLES OF INCORPORATION OF

The undersigned, acting as incorporator of a Florida corporation, hereby adopts the following Articles of Incorporation for such Corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, heretofore adopted by the Florida Legislature, effective January 1, 1985, as amended, and the Secretary of State, Tallahassee, Florida.

**ARTICLE I
NAME**
