The undersigned, acting as the sole incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE ONE

NAME AND ADDRESS

- 1.01. The name of the Corporation is AUSTEX, INC.

ARTICLE TWO

DURATION

- 2.01. This corporation shall commence its existence upon filing of these Articles of Incorporation, and shall exist perpetually thereafter unless sooner dissolved according to law.

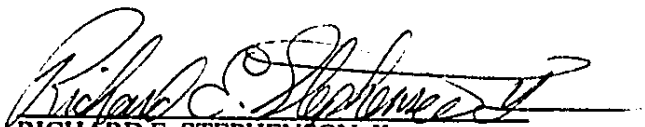

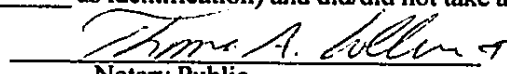

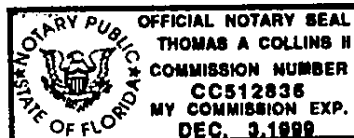
