ARTICLES OF INCORPORATION OF HALF-PINT HANGOUT, INC.

The undersigned incorp rator, for the purpose of forming a corporation pursuant to the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

The name of the corporation is HALF-PINT HANGOUT, INC. (the "Corporation").

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS.
