**ARTICLES OF INCORPORATION**

of

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract hereby form a corporation under the laws of the State of Florida in accordance with Florida Statutes Chapters 621 and 607.

**ARTICLE I**

**CORPORATE NAME**

The name of the corporation is **BRUCE G. KAUFMANN, J.D., P.A.**

**ARTICLE II**

**DURATION**

This corporation shall exist perpetually unless dissolved according to Florida law.

**ARTICLE III**

**PURPOSE**

The corporation, a professional association, is organized for the purpose of engaging in the business of providing legal services and any activities or business permitted under the laws of the United States and the State of Florida which may be directly or indirectly connected to that purpose.

#### **ARTICLE IV**

##### **CAPITAL STOCK**
