The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article 1 - Name and Address

The name of the corporation shall be Florida Aviation Technical Group, inc. and the address of the principle office is 44 Chestnut Cir, Cooper City, FL 33028.

Article 2 - Duration

This corporation shall have perpetual existence.

Article 3 - Purpose
