The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a Corporation under the Laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be: FIRST FLORIDA HOME IMPROVEMENTS, INC.

The principal place of business of this Corporation shall be:
3502 Henderson Blvd., Suite 300, Tampa, FL 33609.

ARTICLE II. NATURE OF BUSINESS

This Corporation may engage in, or transact, any or all lawful activities or business permitted under the Laws of the United States, the State of Florida, or any other State, Country, Territory or Nation. The specific purpose of this Corporation shall be for the purpose of construction and remodeling and related services.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$00.01 per share.

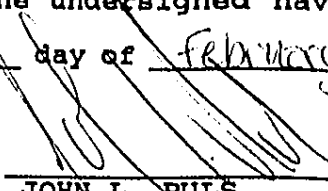

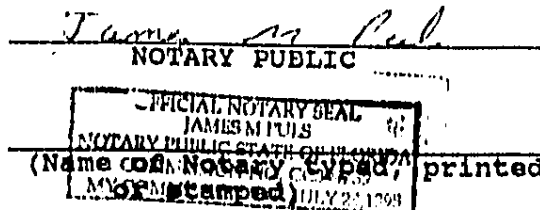
