**ARTICLES OF INCORPORATION
DOLLAR VEND, INC.**

ARTICLE I-NAME

The name of this Corporation shall be DOLLAR VEND, INC.

ARTICLE II-DURATION

The Corporation shall have perpetual existence commencing upon the date of filing of these Articles with the Department of State.

ARTICLE III-PURPOSE

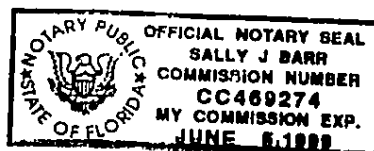
