The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I

NAME OF CORPORATION

The name of the corporation shall be TRISK ENTERPRISES, INC.

The principal place of business of this business shall be 3875 NW 77TH Avenue, Sunrise, Florida 33351.

ARTICLE II

NATURE OF BUSINESS

The nature of this business is computer data entry, analysis and consulting in the United States, the State of Florida or any other state.

ARTICLE III

CAPITAL STOCK

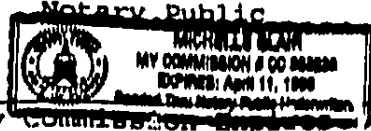
