

ARTICLE I - NAME

The name of this Corporation is Turner Ace Authorized Pest Control, Inc., and the principal business address of the Corporation is 5827 Arlington Road Jacksonville, Florida 32211.

The number of Directors constituting the initial Board of Directors of this Corporation shall be one (1), and the name and address of the person who is to serve as the member thereof is:


