The name and address of the incorporator of this corporation is Mary Lane Hood, 905 Island Grove Rd., DeLand, FL 32724.

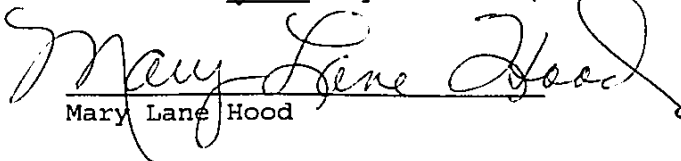
ARTICLE VIII - BY-LAWS

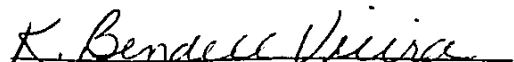

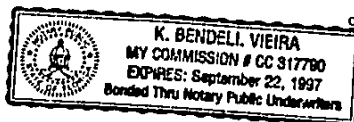
