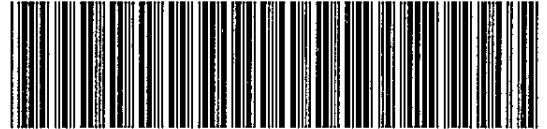



The name of this corporation is **B.I.E., INC.**

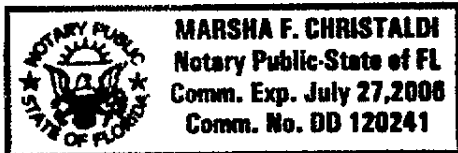
