The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is South Walton Health Plaza, Inc.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose is to acquire property for development associated with health related businesses to be located in south Walton County and/or to engage in any business as permitted under the laws of the United States and the State of Florida.

ARTICLE IV

The corporation shall have authority to issue One Hundred (100) shares of common stock, all of one class, One Dollar (\$1.00) par value.

ARTICLE V

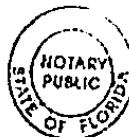


