ARTICLE I - NAME, PRINCIPAL ADDRESS AND MAILING ADDRESS

The name of the Corporation shall be **MARTECH/MILLER INTERNATIONAL, INC.**

ARTICLE II - CAPITAL STOCK

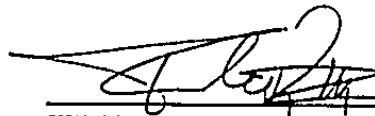
ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT

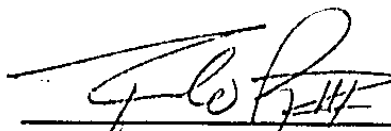
