The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

**Article I - Name**

The mailing address of the initial principal office of the corporation is 916 North Gadsden Street, Tallahassee, Florida 32303.


**Article VIII - Amendment of Articles**


