The undersigned, for the purpose of forming a corporation under the Florida Corporation Act, hereby adopt the following articles of incorporation:

**ARTICLE I**

**Name**

The name of the corporation is Connecticut Broadcast Media of Gainesville, Inc.

**ARTICLE II**

**Duration**

The term of existence of the corporation is perpetual.

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE III**

**Capital Stock**

The aggregate number of shares that the corporation has authority to issue is One Hundred (100), all of which shall be common shares with par value of One Dollar (\$1.00).

**ARTICLE IV**

**Preemptive Rights Granted**

Each shareholder of any class of stock of this corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of the corporation and any securities of the corporation convertible into or carrying a right to subscribe to or acquire any unissued or treasury shares.
