The undersigned subscribers to of these articles incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is: HOLLAND, KOHN, BARNWELL & ASSOCIATES, INC.

The general nature of the business to be transacted by this corporation is to engage in any activities or business permitted under the laws of the United States and Florida.
