The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation.

Article 1 Name

The name of the corporation is SANTA MARTA, INC.

Article II Duration

This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of the State of Florida within five (5) business days after executed and acknowledged, corporate existence shall commence upon filing by the Department of State.
