ARTICLE L- CORPORATE NAME

The name of the corporation shall be Beach & Bay Realty, Inc.

ARTICLE II - DURATION

The duration of the corporation shall be perpetual, unless dissolved according to the laws of the State of Florida.

Such rights of indemnification and reimbursement shall not be deemed exclusive of any other rights to which such director, officer, or employee may be entitled under any by-laws, agreement, vote of shareholders, or as a matter of law or otherwise.
