The Undersigned subscribers to these Article of Incorporation, natural persons competent to contract, subscribers to and form a corporation for profit under the laws of the State of Florida.

ARTICLE 1 - NAME

The name of the Corporation is JACKSON'S ROWE ENTERPRISES, INC. The principal place of business shall be at 12530 N.E. 7 AVE. MIAMI, FL. 33161.

ARTICLE 11 - NATURE OF BUSINESS

The corporation may engage in any activity of business permitted under the laws of the United States and of this State. These activities may include, but are not in anywise limited to the operation of the following:

- a) To engage in the business of Health Food Products; such as selling vitamins, health books, non-alcoholics beverage, and nutritious food products.
- b) To engage in the business of Spiritualist; such selling spiritual products, which include candles, incense and spiritual books.



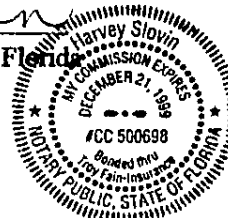


