ARTICLES OF INCORPORATION  
of  
BALLOWE REPORTING SERVICE, INC.

ARTICLE I - Name and Address

The Name of this corporation is BALLOWE REPORTING SERVICE, INC. (hereafter referred to as the Corporation). The Corporation's principal address is The 110 Tower, Suite 1840, 110 SE. 6th Street, Ft. Lauderdale, Florida 33301.

ARTICLE II - Duration

This Corporation shall have perpetual existence commencing on the date these articles of incorporation are filed with the Florida Department of State.

ARTICLE III - Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - Powers

This Corporation shall have all the powers conferred upon corporations organized under the laws of the Florida Statutes.

ARTICLE V - Capital Stock

This Corporation is authorized to issue 100 shares of One and no/100 Dollar (\$1.00) par value common stock.
