# ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF HEALTHTREND CONSULTING, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, HEALTHTREND CONSULTING, INC. ("Corporation"), adopts the following Articles of Amendment to its Articles of Incorporaton:
