Article I. Name

The name of this corporation is Capitol Homes, Inc.

Article II. Initial Principal and Registered Office and Agent

The initial principal office and mailing address of the corporation and the street address of the initial registered office is 1612 Chadwick Way, Tallahassee, Florida 32312. The initial registered agent is Lance Edward Leininger.

Article III. Capital Stock

This corporation is authorized to issue 10,000 shares of \$1.00 per share par value common stock.

Article V. Management of Corporation by Shareholders



Pursuant to the provisions of Section 607.0501(3) of the Florida Statutes (1995), the undersigned hereby:


1. Accepts his appointment as registered agent of Capitol Homes, Inc., a Florida corporation ("the corporation"), and agrees to act in this capacity;
