

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME OF CORPORATION

The name of the corporation is ORANGE BLOSSOM HOTEL, INC.

ARTICLE TWO

PRINCIPAL OFFICE

The principal office of the corporation will be 710 EAST MICHIGAN STREET #47, ORLANDO, FLORIDA 32806.

ARTICLE THREE

PURPOSE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE FOUR

INITIAL CAPITAL

The amount of initial capital with which this corporation shall begin business shall be five hundred (\$500.00) dollars.
