ARTICLES OF INCORPORATION  
OF

The undersigned subscriber of these Articles of Incorporation, natural person competent to contract, hereby associates himself to form a corporation under the laws of the State of Florida.

**FIRST:** The name of the corporation is: J.E.C.K., INC.
