#### **ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a corporation, adopts the following Articles of incorporation:

### ARTICLE I

#### NAME

The name of the corporation is Swell Art & Design, Inc., and its address is 3054 Lakewood Drive, Ft. Lauderdale, Florida 33332.

#### **DURATION**

The duration of the corporation is perpetual.
