I, THE UNDERSIGNED, DESIRE TO BECOME A BODY CORPORATE, AND STATE INCORPORATOR, DO HEREBY MAKE AND FILE THESE ARTICLES OF INCORPORATION FOR A PROPOSED CORPORATION PURSUANT TO THE LAWS OF FLORIDA, AND TO THAT END DECLARE:

ARTICLE I - NAME

THE NAME OF THIS CORPORATION SHALL BE: LLOYD'S PHOTOGRAPHY, INC.

ARTICLE II - NATURE OF BUSINESS
