ARTICLES OF INCORPORATION

OF

MULTIMARKET-AMERICAS CORP.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following

ARTICLE ONE

NAME

The name of the corporation is Multimarket-Americas Corp.

The principal place of business shall be: 6595 N.W. 36 Street Suite 220, Minmi, Florida 33166

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual, commencing on the date of receipt and acknowledgment of the Articles by the Secretary of State.

The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the corporation.
