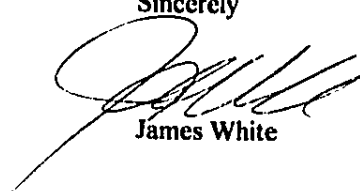

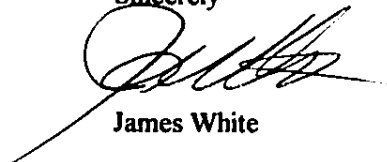

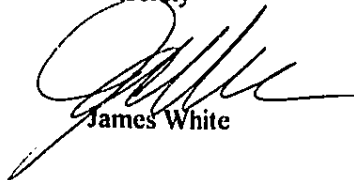

ARTICLE I - NAME

The name of this corporation is **Environmental Coastal Construction, Inc.**, a Florida Corporation.

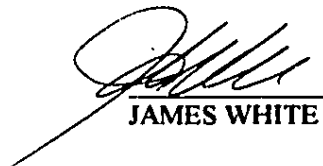
